A BILL

To prohibit military assistance to countries that engage in
arms transfers and activities with respect to Iran, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Arms Sales to Iran
5 Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) United Nations Security Council Resolution
2 2231 (2015) which endorses implementation of the
3 Joint Comprehensive Plan of Action also provides
4 restrictions on ballistic missile-related transfers to or
5 activities with Iran absent case-by-case approval by
6 the United Nations Security Council.

7 (2) Iran has conducted at least three ballistic
8 missile tests since implementation of the Joint Com-
9 prehensive Plan of Action in 2015.

10 (3) Iran continues to pursue a policy of desta-
11 bilization throughout the Middle East, relying on
12 proxies and direct military engagement to challenge
13 United States partners and threaten Israel.

14 (4) Various countries have reportedly proposed
15 arms transfers to or activities with Iran despite
16 Iran's ongoing regional aggression.

17 **SEC. 3. SENSE OF CONGRESS.**

18 It is the sense of Congress that—

19 (1) arms transfers to or activities with Iran
20 would empower Iran to further destabilize the region
21 and would undermine core objectives of regional
22 peace; and

23 (2) the Secretary of State, through bilateral en-
24 gagement and multilateral fora, should diplomati-
25 cally engage with the governments of countries that

1 have reportedly proposed arms transfers to or activi-
2 ties with Iran and with other United Nations Secu-
3 rity Council member states in order to prevent such
4 transfers or activities.

5 **SEC. 4. REPORT.**

6 Not later than 90 days after the date of the enact-
7 ment of this Act, and annually thereafter, the Secretary
8 of State shall submit to Congress a report on each covered
9 activity or transfer, and the diplomatic responses of the
10 United States to each such covered activity or transfer,
11 that is proposed during the one-year period preceding the
12 date of the submission of the report.

13 **SEC. 5. PROHIBITION ON MILITARY ASSISTANCE TO COUN-**
14 **TRIES THAT ENGAGE IN ARMS TRANSFERS**
15 **AND ACTIVITIES WITH RESPECT TO IRAN.**

16 (a) IN GENERAL.—Subject to subsection (c), and ef-
17 fective beginning on the date that is 180 days after the
18 date of the enactment of this Act—

19 (1) no military assistance, including military as-
20 sistance furnished under the Foreign Assistance Act
21 of 1961, the Arms Export Control Act, or any other
22 provision of law, may be provided to a country that
23 engages in any covered activity or transfer; and

24 (2) no license may be granted to export an item
25 on the United States Munitions List under section

1 38 of the Arms Export Control Act (22 U.S.C.
2 2778) or any other provision of law to any country
3 that engages in any covered activity or transfer.

4 (b) WAIVER.—The President may waive the prohibi-
5 tions under subsections (a) on a case-by-case basis with
6 respect to a particular country if the President determines
7 and reports to the appropriate congressional committees
8 that it is important to the national interest of the United
9 States to do so.

10 **SEC. 6. DEFINITIONS.**

11 In this Act:

12 (1) APPROPRIATE CONGRESSIONAL COMMIT-
13 TEES.—The term “appropriate committees of Con-
14 gress” means—

15 (A) the Committee on Armed Services, the
16 Committee on Foreign Affairs, and the Com-
17 mittee on Appropriations of the House of Rep-
18 resentatives; and

19 (B) the Committee on Armed Services, the
20 Committee on Foreign Relations, and the Com-
21 mittee on Appropriations of the Senate.

22 (2) COVERED TRANSFER OR ACTIVITY.—The
23 term “covered activity or transfer” means any arms
24 transfer to or activity with Iran described in para-
25 graphs 2, 4, and 5 of Annex B of United Nations

1 Security Council Resolution 2231 (2015) with re-
2 spect to which a country has sought approval by the
3 United Nations Security Council under such Resolu-
4 tion.

5 (3) JOINT COMPREHENSIVE PLAN OF ACTION.—
6 The term “Joint Comprehensive Plan of Action”
7 means the Joint Comprehensive Plan of Action,
8 agreed to at Vienna July 14, 2015, by Iran and by
9 the People’s Republic of China, France, Germany,
10 the Russian Federation, the United Kingdom and
11 the United States, with the High Representative of
12 the European Union for Foreign Affairs and Secu-
13 rity Policy, and all implementing materials and
14 agreements related to the Joint Comprehensive Plan
15 of Action, and transmitted by the President to Con-
16 gress on July 19, 2015, pursuant to section 135(a)
17 of the Atomic Energy Act of 1954, as amended by
18 the Iran Nuclear Agreement Review Act of 2015
19 (Public Law 114–17; 129 Stat. 201).
